I need some information regarding road construction concerned with my village. Kindly provide information regarding :

- a) The status of the connectivity of Bishanpur village to nearest town/city (Nathnagar / Bhagalpur) by road.
- b) As the construction of road is in process, kindly provide the details of road construction in terms of cost and completion of the road construction.
- c) What is the standard of laying of bricks on the both side of roads after construction the road. (As observed in the village area of Bishanpur the area of laying bricks on both road sides may not compliance the standards as per actual work done. The bricks are being jointed without cement and sand mortar which may lead to loss of constructed works within short span of time and huge loss of public money spend through Govt. channels on public works.
- d) Also, inform that the expected completion time of construction of uncompleted roads between Nathnagar and Bishanpur as there are roads construction in progress but still some locality between Raghapur and Dudhela are in pathetic condition and causing the loss of goods and general public safety oftenly.
